(The teen leadership--JYM Clerks and Clerk of JYM Ministry and Oversight--are your first resources if they are awake, along with fellow FRAPs and JYM Adult Committee members.)
  
- 7) Are you interested in being a Day FRAP (after breakfast to dinner time) or a Night FRAP (after dinner to breakfast)? We prefer that FRAPs work all 5 days/nights but if you can only do part time please apply and clearly state "Part-time." Full time in both categories will have priority because continuity is important.
  
- 8) If you are a Night FRAP, are you prepared to be available all night in a living area where teens may be up late? (FRAPs will sleep in the same area as the teens; girls and boys will be in separate areas. They usually set a lights-out time between midnight and one a.m.) Any questions or concerns?
  
- 9) Do you have any special needs, physical limitations, or requests?
  
- 10) Do you have other PYM responsibilities that might conflict? If so, what times are those scheduled?

Please state briefly their position and/or relationship to you in terms of your experience with youth. (Preferably at least one from a Quaker setting if possible.)
